Det Raul Delgadillo

Detective Raul Delgadillo has been a police officer for 21 years. He began his career with the Azusa Police Department before moving to the San Diego Police Department where he is currently a detective assigned to the Criminal Intelligence Unit (CIU). His duties while assigned to CIU are to monitor Mexican drug trafficking organizations as well as organized crime that operate both in Tijuana, Mexico and San Diego, California.

Prior to being assigned to CIU, Raul was assigned to the Homicide Unit where he was responsible for investigating homicides including but not limited to gangs, domestic violence, child abuse resulting in death and officer involved shootings.

Raul also held the position of Mexican Liaison for the San Diego Police Department for 6 years. While in that assignment, he was tasked with monitoring organized

crime activity both in and out of Mexico, to monitor the Mexican political climate, to seek and apprehend suspects throughout Mexico and arrange for their deportation and extradition to the United States. In addition, he was responsible for handling the dignitary protection detail for any San Diego government official traveling into Mexico including the United States "Drug Czar."

Raul also assisted the Federal, State, and Municipal Mexican government in conducting investigations in the United States. He further provided Mexican government official with protection details during their official visits to the United States. Lastly, Raul participated in numerous kidnapping investigations, money drops and rescue operations while working in conjunction with the Mexican Anti- Kidnapping Unit in Tijuana, Mexico.

Detective Delgadillo also obtained expertise in Gang investigations while assigned to the Street Gang Unit. when he was assigned to monitor and investigate the Mexican gangs operating in San Diego. Prior to the Street Gang Unit, Detective Delgadillo was assigned to the Narcotics Unit where he conducted street and mid-level narcotic investigations. Before becoming a Detective, he worked patrol for Central Division which is a primarily Hispanic gang community.

Raul has worked as an undercover operative to include long-term operations involving gangs, cartels, anarchist, drugs and weapon trafficking. During many of those undercover operations, Raul worked together with numerous Local, State and Federal Agencies.

Kevin R. Davis



Kevin R. Davis is a full-time officer with more than 25 years in law enforcement. Previous assignments include patrol, corrections, and plainclothes narcotics investigations. He's a former SWAT operator, team leader and instructor currently assigned to the training bureau where he specializes in use of force, suspect control and firearms training.

Bobby Smith



When speaking, Bobby shares his education and experiences of his 25 year law enforcement career. He also reveals the traumatic events of his life, including the incident on LA15 in March of 1986 when he was left blind after a shotgun blast to the face by a drug offender while in the line of duty.

Bobby Began his career in criminal justice by studying at the University of Louisiana at Monroe and by working as a police officer at local police agencies and later advancing to the Louisiana State Police. His assignments have included patrol, investigations, narcotics, personnel and training. Bobby earned a Bachelors of Arts degree in Criminal Justice, and after being shot, a Masters Degree in Education, and a doctorate in Counseling Psychology. Nearly 20 years of speaking, Bobby has provided training and motivational presentations to over one million people. He has been interviewed by television, radio, magazine, and newspaper reporters from across the nation. Bobby has even hosted his own television and radio shows on dealing with trauma. 2 MNOA Scholarship Awards

This youth scholarship sponsored by the Montana Narcotics Officers Association was created in 2009. It is another way to provide a benefit to MNOA members and their families as well as show our belief in and support for our Montana youth.

To be eligible; the student must (1) be a resident of the state of Montana; (2)*immediate family member of a current MNOA member in good standing for at least one year; (3) be currently enrolled in a college, university or trade school (or) be a graduating high school senior who has been accepted to a college, university or trade school; (4) reference form completed by community leader/teacher on behalf of applicant; (5) write and submit an essay of a maximum of 500 words on why drugs should or should not be legalized.

An appointment committee consisting of four (4) MNOA board members will select one (2) student's to receive a \$1,000.00 scholarship. The scholarship will be paid directly to the college, university or trade school of your choice, mid-January 2012, after a successful first semester.

Completed application packets are due on or before February 1st, 2011. Late applications will not be accepted. Your signature on the application form signifies that all information included is true and accurate to the best of your knowledge.
