## Congratulations

Montana Highway Patrol Troopers Tim Lytle and Troy Muri were recently recognized by the Drug Enforcement Administration for their outstanding contributions and invaluable assistance to the DEA Billings Resident Office. During 2005 Troopers Lytle and Muri went above and beyond their patrol duties and helped revitalize interdiction efforts in the State of Montana. During March and April 2005 Lytle and Muri were responsible for the seizure of over \$600,000 on three separate stops. The investigations further led to financial seizures in Oregon.

DEA also recognized MHP Trooper Michael Donnely for his outstanding contributions and invaluable assistance to DEA. Between January 2006 and March 2006 Trooper Donnelly's interdiction efforts resulted in the seizure of 30 kg cocaine, 9,000 diazepam pills, 229 10ml viles of ketamine, 90 pounds of BC Bud, a half pound of methamphetamine and over \$20,000 in currency, and the arrest of numerous suspects on different vehicle contacts.
